Show Rules

- 1. This will be an Official ARBA show governed by the Official Show Rules in the 2016-2020 ARBA Yearbook. All rabbits & cavies will be judged by the ARBA Standard of Perfection 2016-2020 edition
- 2. Parents are responsible for your children and any damage they may cause!
- 3. Exhibitors are responsible for any damages they cause to the show facilities
- 4. Exhibitors may only groom their animals in designated areas provided and approved by the show committee
- 5. Chairs and grooming tables in designated areas only and only as space permits
- 6. All exhibitors are required to comply with facility rules, BVRBA/MVRBA/PCF show rules, ARBA show rules, and local laws and regulations. All decisions and interpretations of the show committee are final and binding and are made in the best interest of the exhibitors and the overall event
- 7. Attendees who do not follow the direction of the show committee and decisions made may be asked to leave and may be barred from future events
- 8. Carriers must have a leak proof bottom
- 9. The Show Committee may change showing order and judges at any time during the show

- 10. All animals must have permanent and legible ear marks according to ARBA rules
- 11. Animals without permanent, legible identification in the left ear will be disqualified with no entry fees refunded
- 12. Any animals showing signs of disease will be removed from the showroom and entry fee(s) forfeited
- 13. Animals disqualified for contagious disease shall be removed from the showroom
- 14. Exhibitors attempting to or interfering with the judges or show committee or acting in an unbecoming manner an exhibitor shall have their stock disqualified and shall be rejected and barred from the show with entry fee forfeited
- 15. Boise Valley Rabbit Breeders Association, Magic Valley Rabbit Breeders Association, Pioneer Cavy Fanciers and the Boise Factory Outlets will not be responsible in the case of fire, theft, injury, or providential loss. Every precaution will be taken to prevent these losses
- 16. In the event there is a dispute over the placement of an animal, whatever is found on the control sheets is considered correct in all instances
- 17. No refunds of entry fees unless the entire show is cancelled. If you are unable to come to the show for any reason, you still need to pay your entry fee unless you notify the show secretary at least 36 hours in advance of the start of the show
- 18. The open shows will not be delayed due to specialty show judging, be certain to get your animals to the tables in a timely manner
- 19. Please do not block the walkway between tables rows and judging tables
- 20. Please do not bring several carriers up to the judging tables
- 21. All awards must be picked up the day of the show. No awards will be mailed
- 22. The show officials reserved the right to add or substitute judges as deemed necessary
- 23. No animals other than rabbits or cavies are permitted in the showroom with the exception of service dogs
- 24. No rabbit under their breed's minimum weight and 8 weeks of age are sold at the show. This is to protect the seller and buyer
- 25. All rabbits and cavies will be judged as written on the entry forms and all changes must be approved by the show secretary
- 26. Please fill out your entry form completely and legibly. Please include Ear number, Breed, Variety, Class and Sex!! You will be called to verify any information. Ear Changes \$ 2.00 each. You may only make ear changes in the same class, sex, and variety as entered
- 27. All cavies must have an ear tag in the left ear

- 28. Make all checks payable to Boise Valley RBA or Magic Valley RBA or Pioneer Cavy Fanciers in US Funds. In addition to any bank charges, a \$35.00 fee will be charged for any returned checks
- 29. All entries must be paid whether the rabbits or cavies are judged or not. This include entries made by e-mail. Entries not paid for, will be billed
- 30. Judges decisions will be final
- 31. With the exception of the judge, show secretary, show superintendent, members of the show committee and the table scribe no one will be allowed behind the tables
- 32. No shavings as our showroom has industrial carpeting. Exhibitors may use wood pellets or paper bedding.


